Riverside Tutors and Homework Helpers Terms and Conditions

Riverside Tutors and Homework Helpers (RT&HH) only undertake business on the following terms and conditions. These terms and conditions may be amended only by agreement, in writing, of you and RT&HH

- 1) Registration and sessional fees for the introduction of a Tutor or Homework Helper (Service Provider) are payable in advance. The Service Provider is paid directly by the family for the services they are directly supplying to the family. Each time the pre-purchased sessions are used up and need to be re-purchased from RT&HH, the family will pay RT&HH for the next session or bundle of sessions before continuing to use the services of the Service Provider.
- 2) RT&HH is not responsible for any matter relating to tax or NI
- 3) The family must notify RT&HH as soon as reasonably practical if a Service Provider services are to be used including subsequent engagements
- 4) If without the RT&HH's written consent, you introduce a Service Provider to any person, you shall be liable for the session fees and incurred Registration Fee should the Service Provider supply services to that other person
- 5) The client shall not use the services of the Service Provider otherwise than through Riverside
- 6) RT&HH must be given notice at least 24 hours in advance in the event of cancellation and by 1pm on Friday if the session is to take place over the weekend or suitably in advance if there is a public holiday. The cancellation must be received by RT&HH in writing either by email or fax. Cancellations left on our answer phone will not be accepted unless received in writing within the required timeframe. If a session is cancelled on the day the Service Provider will be due payment to cover loss of earnings.
- 7) RT&HH endeavours to ensure the suitability of any Service Provider provided. The client should satisfy himself or herself of the suitability.
- 8) The Client shall advise RT&HH of any special health and safety matters about which Riverside is required to inform the Service Provider and about any requirements imposed by law or by any professional body, which must be satisfied if the Service Provider is to provide the service
- 9) RT&HH shall not be liable (and the Client agrees and acknowledges that in the circumstances of Riverside and obligations of the Client that this provision is reasonable) for any acts, omissions, default, loss or damage caused or contributed to, by the Service Provide

Please note: Best practice for all Service Providers involved in the care of Children requires that a Criminal Record Bureau check be produced by every Service Provider. However the Criminal Record Bureau is not absolute assurance that any person is suitable for the care of children. You should check the date of the Criminal Record Bureau Check. It will not record matters occurring after its date and may not record matters arising within the short period before its issue. However not every country has an exact equivalent of the Criminal Record Bureau system.
